No. II(2)/ECCF/855/2022.—In exercise of the powers conferred by Section 16 of the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the Governor of Tamil Nadu hereby declares that the area, the boundaries of which are specified in the Schedule below, as reserved forest with effect on and from 18.04.2023.

**North.-** Generally, the northern boundary line starts from the tri-junction points of Survey Numbers 481/1, 481/2 and 409, No.23, Musuvanuthu Village, runs towards the east side along the southern boundary of Survey Numbers 409, 375, 374, 373, 372, 362 and 361 of No.23, Musuvanuthu Village and till it reaches the tri-junction point of Survey Numbers 361, 334 and 481/1 of No.23, Musuvanuthu Village.

**East.-** Thence, the eastern boundary runs towards southern side along the western boundary of Survey Numbers 334, 333, 332, 331, 330, 329 and 326 of No.23, Musuvanuthu Village and till it reaches the tri-junction point of Survey Numbers 326, 483 and 481/1 of No.23, Musuvanuthu Village.

**South.-** Thence, the boundary runs towards west side along the northern boundary of Numbers 483, 482 and 324 of No.23, Musuvanuthu Village, No.18, Sithargalnatham Village, No.28, Kullichettipatti Village and No.27, Bodigoundanpatti Village and till it reaches the tri-junction point of Survey Numbers 481/1, 481/2 of No.23 Musuvanuthu Village and No.27, Bodigoundanpatti Village.
