No. SRO B-54/2022.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

The rules hereby made shall come into force on and from the date of issue of this order.

RULES

The Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts in the Tamil Nadu General Service shall apply to the holders of the temporary post of Joint Director (Technical) in the Department of Archaeology, subject to the following modifications:-

2. Constitution.- The post shall constitute a distinct Class of the said service.

3. Appointment.- Appointment to the post shall be made,-

(i) by promotion from among the holders of the post of Deputy Director/Deputy Superintending Archaeologist in the Department of Archaeology; or

(ii) If no eligible person is available for appointment by the above method, appointment by deputation for a period not exceeding three years from the post of,-

(a) Deputy Superintending Archaeologist in the Department of Archaeological Survey of India: or

(b) Assistant Professor, Archaeology from any University or Institution recognized by the University Grants Commission.

4. Appointing Authority.- The Appointing authority for the post shall be Government.

5. Qualifications.- No person shall be eligible for appointment to the post by the methods specified in column (2) of the Table below, unless he possesses, the qualifications, specified in the corresponding entries in column (3) thereof:-

6. Pay.- There shall be paid to the holder of the post, a monthly pay calculated in the pay matrix Rs. 61,900-Rs. 2,28,100 (Level-26)

7. Preparation of annual list of approved candidates.- For the purpose of preparation of annual list of approved candidates for appointment to the post, the crucial date on which the candidate shall have acquired the prescribed qualification shall be the 1st September of every year.

No. SRO B-55/2022.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

The rules hereby made shall come into force and from the date of issue of this order.

RULES

The Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent post in Category 3 in Branch-I of the Tamil Nadu Engineering Services shall apply to the holders of the temporary post of Executive Engineer in the Department of Archaeology, Chennai, subject to the following modifications:-

2. Constitution.- The post shall constitute a separate category in the said class of the said service.

3. Appointment.- Appointment to the post shall be made as follows:-

(i) by promotion from among the holders of the post of Assistant Executive Engineer in the Department of Archaeology;

(ii) If no eligible person is available for appointment by the above method, by deputation for a period not exceeding three years from the post of Deputy Superintending Archaeological Engineer in the Department of Archaeological Survey of India.

(iii) If no eligible person is available for appointment by the above methods, by transfer from among the holders of the post of Executive Engineer in Public Works Department;

(iv) If no eligible person is available for appointment by the above three methods, by recruitment by transfer from any other service.

4. Appointing Authority.- The Appointing authority for the post shall be the Government.

5. Qualifications:- No person shall be eligible for appointment to the post by the method specified in column (2) of the Table below, unless he/she possesses, the qualifications, specified in the corresponding entries in column (3) thereof:-

6. Probation.- Every person appointed to the post by recruitment by transfer from any other service shall, from the date on which he/she joins duty, be on probation for a period of one year on duty within a continuous period of two years.

7. Pay.- There shall be paid to the holder of the post a monthly pay calculated in the scale of level 25 Rs. 59,300-Rs. 2,17,600 (Level-25)

8. Preparation of annual list of approved candidates.- For the purpose of preparation of annual list of approved candidates for appointment to the post, except for the method of by Deputation, the crucial date on which the candidate should have acquired the prescribed qualification shall be the 1st September of every year.

RULES

The rules hereby made shall come into force on and the date of issue of this order

RULES

The Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts in Category 1 in Branch-IX of the Tamil Nadu Engineering Subordinate Service shall apply to the holders of the temporary post of Junior Engineer (Electrical) in the Department of Archaeology, subject to the following modifications:-

2. Constitution.- The post shall constitute a separate category in the said class of the said service.

3. Appointment.- Appointment to the post shall be made:-

(i) by recruitment by transfer from any other service in the department of Archaeology; (or)

(ii) If no eligible person is available for appointment by the above method, by transfer from among the holders of the post of Junior Engineer (Electrical) in Public Works Department;

(or)

(iii) If no eligible person is available for appointment by the above two methods, by recruitment by transfer from any other service; (or)

(iv) If no eligible person is available for appointment by the above three methods, by direct recruitment.

4. Appointing Authority.- The appointing authority for the post shall be Commissioner / Director, Department of Archaeology.

5. Qualifications:-

(a) Age:-

No person shall be eligible for appointment to the post by direct recruitment, if he has completed the age of 32 years on the first day of July of the year in which the vacancy is notified.

(b) Other qualifications:-

No person shall be eligible for appointment to the post by the method specified in column (2) of the table below unless he/she possesses, the qualifications, specified in the corresponding entries in column (3) thereof:-

6. Reservation of appointment.-

The rule of reservation of appointment [Section 27 of the Tamil Nadu Government Servants (Conditions of Service, Act, 2016 shall apply for appointment by direct recruitment, if the cadre strength is more than one.

7. Probation.-

(a) Every person appointed to the post by direct recruitment shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

(b) Every person appointed by recruitment by transfer from any other service, shall from the date on which he joins duty be on probation for a period of one year on duty within a continuous period of two years

8. Test.- Every person appointed to the post by direct recruitment or by recruitment by transfer must pass Account Test for the Public Works Department Officers and Subordinates within the period of probation.

9. Pay.- There shall be paid to the holder of the post a monthly pay calculated in the scale of pay Rs. 35900-Rs. 1,31,500 (Level-13)

10. Preparation of annual list of approved candidates.-

For the purpose of preparation of the annual list of approved candidates for appointment to the post, the crucial date on which the candidate should have acquired the prescribed qualifications shall be the 1st September of every year.
