

#### The Tamil Nadu Protected Agricultural Zone Development Act, 2020

No. II(1)/AG/8/2022.

[Agriculture and Farmers Welfare-Tamil Nadu Protected Agricultural Zone Development Act, 2020-Appointment of new members for Tamil Nadu Protected Agricultural Zone Development Authority under Section 6(1) of the TANPAZD Act, 2020-Orders-Issued].

#### ORDER: No.265, Agriculture (AP 5), 30th December 2021.

Based on the announcement made by the then Hon'ble Chief Minister on 09.02.2020, a bill was passed on 19.02.2020 in the Tamil Nadu Legislative Assembly and the Government of Tamil Nadu has enacted "Tamil Nadu Protected Agricultural Zone Development Act, 2020" and published in the *Tamil Nadu Government Gazette* on 21.2.2020 by converting Thanjavur, Nagapattinam (Mayiladuthurai is now announced as District), Thiruvarur districts and Aranthangi, Avudaiyarkoil, Karambakudi, Manamelkudi and Tiruvarangulam blocks of Pudukottai and Kattumannarkoil, Melbhuvanagiri, Keerapalayam, Parangipettai and Kumaratchi blocks of Cuddalore Districts as Protected Agricultural Zone.

2. As per section 5(1) of the above said Act, the following members were nominated for the Tamil Nadu Protected Agricultural Zone Development Authority under the chairmanship of Hon'ble Chief Minister of Tamil Nadu:-

- i. The Chief Minister–Chairperson;
- ii. The Deputy Chief Minister-member
- iii. The Minister for Finance-member;
- iv. The Minister for Law-member;
- v. The Minister for Agriculture member;
- vi. The Minister for Environment–member;
- vii. The Minister for Rural Development and Local Administration member;
- viii. The Minister for Industries-member;
- ix. The Minister for Rural Industries-member;
- x. The Minister for Animal Husbandry-member;
- xi. The Minister for Fisheries-member;
- xii. The Chief Secretary to Government-member, ex-officio;
- xiii. The Agricultural Production Commissioner and Secretary to Government, Agriculture Department–member-secretary, ex- officio;
- xiv. The Secretary to Government- Finance Department-member,- ex-officio;
- xv. The Secretary to Government, Animal Husbandry, Dairying and Fisheries Department- member, ex-officio;
- xvi. The Secretary to Government, Industries Department-member, ex-officio;
- xvii. The Secretary to Government, Rural Development and Panchayat Raj Department-member, ex-officio:
- xviii. The Secretary to Government, Environment and Forest Department-member, ex-officio;
- xix. The Secretary to Government, Housing and Urban Development Department-member, ex-officio;

- xx. The Secretary to Government, Public Works Department-member, ex-officio;
- xxi. The Vice-Chancellor, Tamil Nadu Agricultural University member, ex-officio;
- xxii. A Member of Parliament and two Members of Legislative Assembly representing the protected agricultural zone to be nominated by the Government–members;
- xxiii. Three representatives of farmers to be nominated by the Government-members;
- xxiv. One expert each in the field of Agricultural Science, Horticultural Science and Veterinary and Animal Science to be nominated by the Government-members.

3. Subsequently, in the Government order second read above, the Government framed "Tamil Nadu Protected Agricultural Zone Development Rules, 2020" and the same was published in the Tamil Nadu Government Gazette (TNGG) on 26.8.2020 *vide* reference third read above. Under section 8 of the TANPAZD Act, 2020 and rule 4 of TANPAZD Rules, 2020, the Authority has been empowered to carry out various functions like fostering infrastructure for Food Security, Policies for protection and development, steps to Increase agricultural production and productivity, promotion of agro based and allied Industries in the Tamil Nadu Protected Agriculture Zone besides suggesting measures for preserving agricultural land for farming, allied activities for providing stability to the farming economy, etc., for overall development of this zone.

4. Consequently, in the Government Order fourth read above, the Government have nominated the following members under section 5(1)(xxii) among others, of the TANPAZD Authority constituted by the Government, and it was also notified in *Tamil Nadu Government Gazette* on 30.9.2020 as per section 23(3) of the above said Act *vide* fifth read above:-

#### Member of Parliament:-

1. Thiru.R.Vaithiyalingam.

#### Member of legislative Assembly

- 1. Thiru.O.S.Manian, Hon'ble Minister for Handlooms and Textiles & Member of Legislative Assembly.
- 2. Thiru.R.Kamaraj, Hon'ble Minister for Food and Civil Supplies & Member of Legislative Assembly.

5. When the Government observed, after formation of new Government, the tenure of the above said Members of Legislative Assembly was expired as on 3.5.2021 and also the tenure of the Member of Parliament was expired as on 7.5.2021 by acceptance of his resignation in the Notification sixth read above. Hence, the Government has decided to nominate the following new members for the TANPAZD Authority under section 6(1) of TANPAZD Act, 2020:-

- Thiru. S.S. Palanimanickam, Member of Parliament, Thanjavur Constituency of Tamil Nadu.
- Thiru. Poondi K. Kalaivanan, Member of Legislative Assembly, Thiruvarur Constituency of Tamil Nadu,
- Dr. T.R.B. Rajaa, Member of Legislative Assembly, Mannargudi Constituency of Tamil Nadu.

6. The Government, after careful examination, hereby nominate the following Member of Parliament/Member of Legislative Assembly, as members of Tamil Nadu Protected Agricultural Zone Development Authority, under section 5(1)(xxii) of the Tamil Nadu Protected Agricultural Zone Development Act, 2020:-

- Thiru. S.S. Palanimanickam, Member of Parliament, Thanjavur Constituency of Tamil Nadu.
- Thiru. Poondi K. Kalaivanan, Member of Legislative Assembly, Thiruvarur Constituency of Tamil Nadu.
- Dr. T.R.B. Rajaa, Member of Legislative Assembly, Mannargudi Constituency of Tamil Nadu .
