Amendments to the Special Rules for the Tamil Nadu Revenue Sub-Ordinate Service.

No. SRO B-58/2022.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Revenue Sub-ordinate Service (Section 28 in Volume-III of the Tamil Nadu Service manual, 2016).

2. The amendments hereby made shall be deemed to have to come into force on the 12th day of February 2019.

Amendment

in the said Special Rules, in rule 3, for the expressions under the heading "CATEGORY 2 - DEPUTY TAHSILDARS", the following expressions shall be substituted namely;-

- (a) Recruitment by transfer from the members of the Tamil Nadu Secretariat Service or from the members of the Tamil Nadu Ministerial Service employed in the Revenue Department including the offices of the Commissionerate of Revenue Administration and Disaster Management (including Tamil Nadu State Disaster Management Authority, Commissionerate of Prohibition and Excise), the Commissionerate of Land Administration, the Commissionerate of Civil Supplies and Consumer Protection, the Directorate of Survey and Settlement Department, the Directorate of Adi-Dravidar and Tribal Welfare Department, the Commissionerate of Backward Classes Welfare Department, the Commissionerate of Rehabilitation and Welfare of Non Resident Tamils, the Commissionerate of Urban Land Ceiling/ Urban Land Tax and the Commissionerate of Land Reforms.
- (b) The maximum number of appointments to be made in any particular year by recruitment by transfer from the members of the Tamil Nadu Secretariat Service or / and the member of the Tamil Nadu Ministerial Service employed in the offices of the Commissionerate of Revenue Administration and Disaster Management (including Tamil Nadu State Disaster Management Authority and Commissionerate of Prohibition and Excise), the Commissionerate of Land Administration, the Commissionerate of Civil Supplies and Consumer Protection, the Directorate of Survey and Settlement Department, the Directorate of Adi-Dravidar and Tribal Welfare Department, the Commissionerate of Backward Classes Welfare Department, the Commissionerate of Rehabilitation and Welfare of Non Resident Tamils, the Commissionerate of Urban Land Ceiling / Urban Land Tax, the Commissionerate of Land Reforms as Deputy Tahsildars, shall be made as per the allocation specified in Table below and shall not exceed thirty two in any particular year.
