Amendment to the Special Rules for the Tamil Nadu Horticultural Subordinate Service

No.SRO B-11/2022.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Horticultural Subordinate Service.

The amendments hereby made shall be deemed to have come into force on and from the 28th day of June 2019.

Amendment to the Tamil Nadu Public Service Commission Regulations.

No.SRO B-13/2022.—In exercise of the powers conferred by the proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (Volume-I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 25th February 2019.

AMENDMENT

In the said Regulations, in Part III, in regulation 16, in clause (c), after the fifth proviso, the following proviso shall be added, namely:-

"Provided also that in the case of appointment subsequent to 25th February, 2019, to the category of Assistant Section Officer in the Finance Department in the Tamil Nadu Secretariat Service, by recruitment by transfer from among the holders of the post of Assistant in the Tamil Nadu Ministerial Service or the Tamil Nadu Judicial Ministerial Service, the Commission shall be consulted."
