

No. II(1)/AGFW/5/2023.—In exercise of the powers conferred by sub-section (2) of Section 4 of the Seeds Act, 1966 (Central Act 54 of 1966), the Governor of Tamil Nadu hereby declares the seed Testing Laboratory at Tiruppur as State Seed Laboratory, for the purpose of carrying out analysis of seeds of any notified kind or variety by seed Analyst under that Act.
