**Order No.14, Adi Dravidar and Tribal Welfare (ADW-6)  
23rd January 2023.**

In the Act first read above, Government have enacted the Tamil Nadu State Commission for the Scheduled Castes and Scheduled Tribes Act, 2021 (Tamil Nadu Act 17 of 2021), Dated: 22.09.2021. The Act came into force with effect from 13.10.2021 by a Notification vide Government Order second read above.

2. In the Government Order third read above, the Chairperson, Vice-Chairperson and Members were appointed for the Tamil Nadu State Commission for the Scheduled Castes and Scheduled Tribes.

3. In the Government Order fourth read above, the Tamil Nadu State Commission for the Scheduled Castes and Scheduled Tribes Rules, 2022, Dated: 17.02.2022 was made and Notified.

4. In the Government Order fifth read above, the Chairperson, Vice-Chairperson and the Members were sanctioned Honorarium at the rate Rs. 2,50,000/-, Rs.2,00,000/- and Rs.1,50,000/- respectively per month.

5. In the Act sixth read above, the Tamil Nadu State Commission for scheduled Castes and Scheduled Tribes Act, 2021 has been amended to pay Salaries and Allowances instead to Honorarium to the Chairperson, Vice-Chairperson and the Members of the Commission.

6. In the Government Order seventh read above, amendment has been made to the Tamil Nadu State Commission for Scheduled Castes and Scheduled Tribes Rules, 2022 to pay Salaries and Allowances to the Chairperson, Vice-Chairperson and Members instead to Honorarium and Allowances and the amendment to Act is deemed to come into force from 13.10.2021 which is as follows:-

(a) **For Chairperson:-** The Chairperson of the Commission shall be paid salary and allowances as are admissible to a serving Judge of the High Court:

Provided that if a person appointed as Chairperson, is in receipt of any pension, his salary shall be reduced by the gross amount of pension drawn by him.

(b) **For Vice-Chairperson:-** The Vice-Chairperson shall be paid salary and allowances as are admissible to the rank of Secretary to the State Government.

(c) **For Members:-** The other Members shall be paid salary and allowances as are admissible to the rank of Additional Secretary to the State Government.

7. In the letter eighth read above, the Member Secretary, Tamil Nadu State Commission for the Scheduled Castes and Scheduled Tribes have requested to fix the pay and payment of salary and allowances for the Chairperson, Vice-Chairperson, and the Members of the Commission from the date of their joining as noted against each below as the Act has been amended and it is deemed to come into force with effect from 13-10-2021.

8. The Government after careful examination of the proposal of the Member Secretary hereby accords sanction for payment of salary and allowances from the date of joining and fix the pay of the Chairperson, Vice-Chairperson and Members of the Tamil Nadu State Commission for Scheduled Castes and Scheduled Tribes as below:-

(i) **Chairperson:-** The Chairperson shall be paid the pay of Rs.2,25,000/- per month (as admissible to serving judge of High Court.)

Provided that if a person appointed as Chairperson, is in receipt of any pension, his salary shall be reduced by the gross amount of pension drawn by him.

(ii) **Vice-Chairperson:-** The Vice-Chairperson shall be paid the pay of Rs.1,28,900/- per month at Level 32 / Cell - 1 (128900-261000) of the Pay Matrix.

(iii) **Members:-** The Members shall be paid the pay of Rs. 1,25,200/- per month at Level 31/Cell 1 (125200-254800) of the Pay Matrix.

(iv) The Allowances to Chairperson, Vice-Chairperson and Members may be paid as per orders in force.

9. The Member Secretary while claiming the salary and allowances is hereby instructed to ensure the following:-

I. The salaries and allowances that are to be paid to the officials (for each mensem from the dates of appointment), be reduced by the amount that they have already received as Honorarium.

II. The difference amount may be provided in Revised Estimate 2022-23. The expenditure may be incurred only after the issue of Revised Estimate 2022-23.

III. Any excess claims made for the above officials may also be recovered if the Honorarium paid per month was high.

**Order: No.9, Welfare of Differently Abled Persons (DAP-3.2) 23rd March 2023.**

In the Government Order first read above, orders were issued identifying 235 categories of posts most suitable for the different categories of the Differently Abled Persons in A and B groups for direct recruitment. The Differently Abled Persons with Low Vision (LV), Hard of Hearing (HH), Locomotive Disability (LD), Cerebral Palsy (CP), Leprosy Cured (LC), Dwarfism (DF), Acid Attack Victims (AC) are suitable for the post of Drugs Inspector. Moreover, in the said G.O. the post of the Civil Judge and District Judge (entry level) in Tamil Nadu State Judicial Service the LV, HH, OA, OL, BL, LC, DF and AC categories of have been identified as suitable for Differently Abled Persons, Similarly, for the post of Assistant Director in Housing and Urban Development Department LV, HH, LD (OA, OL), AC, LC and DF categories have been identified suitable for the Differently Abled Persons.

2. In the reference second read above, the Government of India in its Gazette issued Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016 (49 of 2016) in respect of 'Locomotor Disability' category identified/ included under Non-Traumatic Lesions-Scoliosis and / or Kyphoscoliosis as the sub-category apart from other 11 categories.

3. In the reference third read above, the Tamil Nadu Public Service Commission for CCSE-II has sought for clarification to include Locomotor Disability (LD) as additional sub-category to the persons affected by "Spine Kyphoscoliosis" is suitable for the post of Assistant Director in the Tamil Nadu General Service in Town and Country Planning in Housing and Urban Development Department.

4. In the reference 4th read above, the Commissioner for welfare of the Differently Abled has requested to issue amendment to include 'Locomotor Disability' as an additional category to identify the suitability of posts for the Differently Abled Persons affected by "Spine Kyphoscoliosis".

5. In the U.O. 5th read above, the Home Department, has requested to issue an amendment identifying the suitability of all the "Locomotor Disability" category of Differently Abled Persons for the post of District Judge (Entry Level) and Civil Judge in Tamil Nadu State Judicial Service.

6. After careful examination, the Government decided to accept the above requests and to amend with modification in G.O.Ms.No.20, Welfare of Differently Abled Persons (DAP-3 2) Department, dated 20.6.2018 as follows:-
