Constitution of a District Munsif-cum-Judicial Magistrate Court at Viralimalai in Pudukkottai District

(Roc. No. 1555/A/2019/G/Judn)

In exercise of the powers conferred by Section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby fixes Viralimalai in Pudukkottai District as the place at which the District Munsif-cum-Judicial Magistrate Court, Viralimalai, shall be held.
