**Amendments to the Tamil Nadu Water Supply and Drainage Board Service Regulations, 1972
to inclusion of the posts of Hydrogeologist and Senior Hydrogeologist**

In exercise of the powers conferred by sub-sections (1) and (2) of Section 73 of the Tamil Nadu Water Supply and Drainage Board Act, 1970 (Tamil Nadu Act 4 of 1971), the Tamil Nadu Water Supply and Drainage Board with the previous approval of the Government, hereby makes the following amendments to the Tamil Nadu Water Supply and Drainage Board Regulations, 1972 published at pages 1 to 51 of Supplement Part-V of the *Tamil Nadu Government Gazette*, dated the 20th December 1972.

(2) The amendments hereby made shall be deemed to have come into force on and from the 20th November 1976.

AMENDMENTS

In the said Regulations,-

(1) in regulation 5, under the heading "II. Tamil Nadu Water Supply and Drainage Board Engineering Service",-

(a) after category "2. Superintending Engineer", the following category shall be inserted, namely:-

"2-A Senior Hydrogeologist.;"

(b) after category "3. Executive Engineers (including Deputy Chief Engineer)", the following category shall be inserted, namely:-

"3-A Hydrogeologist.;"

(2) in regulation 19, in the TABLE, under sub-regulation (2) in clause (a),-

(a) after category "2) Superintending Engineers" in column (1) and the corresponding entry in column (2) thereof, the following category and entry shall, respectively, be inserted, namely:-

"2-A) Senior Hydrogeologist By promotion from the Hydrogeologist of category (3-A).;"

(b) after category "3) Executive Engineers" in column (1) and the corresponding entry in column (2) thereof, the following category and entry shall, respectively, be inserted, namely:-

"3-A) Hydrogeologist By promotion from the Deputy Hydrogeologist of category 8.;"

(3) in regulation 20, in the TABLE, under the heading "II Tamil Nadu Water Supply and Drainage Board Engineering Service",-

(a) after category "2. Superintending Engineers" in column (1) and the corresponding entry in column (2) thereof, the following category and entry shall, respectively, be inserted, namely:-

"2- A. Senior Hydrogeologist Board.;"

(b) after category "3. Executive Engineers" in column (1) and the corresponding entry in column (2) thereof, the following category and entry shall, respectively, be inserted, namely:-

"3-A. Hydrogeologist Managing Director.;"

(4) in regulation 23, in the TABLE, under the heading "II Tamil Nadu Water Supply and Drainage Board Engineering Service",-

(a) after category "2. Superintending Engineer" in column (1) and the corresponding entries in columns (2) and (3) thereof, the following category and entries shall, respectively, be inserted, namely:-

"2-A. Senior Hydrogeologist By promotion from Hydrogeologist of category 3-A. Must have rendered service as Hydrogeologist for a period of not less than two years.";

(b) after category "3. Executive Engineer" in column (1) and the corresponding entries in columns (2) and (3) thereof, the following category and entries shall, respectively, be inserted, namely:-

"3-A. Hydrogeologist By promotion from Deputy Hydrogeologist of category 8. Must have rendered service as Deputy Hydrogeologist for a period of not less than three years.";

(5) in regulation 49, in the TABLE, under the heading "Chief Engineers Office and Subordinate Offices",-

(a) after category "2. A Superintending Engineer" in column (1) and the corresponding entry in column (2) thereof, the following category and entry shall, respectively, be inserted, namely:-

"AA. Senior Hydrogeologist Managing Director.";

(b) after category "2.B. Executive Engineer" in column (1) and the corresponding entries in column (2) thereof, the following category and entry shall, respectively, be inserted, namely:-

"BB. Hydrogeologist Managing Director.";
