The Hon'ble Chief Minister of Tamil Nadu has made the following announcement No.16 on the floor of the Assembly during the Police Demand No.22 on 09.05.2022:

- 2. Accordingly, the Government of Tamil Nadu is pleased to institute an Award named "Tamil Nadu Chief Minister's Police Medal for outstanding work in eradicating the drug production and illicit trafficking in the State" to be conferred to the Police Officers from the rank of Superintendent of Police (All India Service and State Police) Service and downwards up to the Police Constables and hereby make the following rules governing the award of the said Medal:-
- (i) This Medal shall be designated as" Tamil Nadu Chief Minister's Police Medal for outstanding work in eradicating the drug production and illicit trafficking in the State "and the number of medals shall not exceed five in a year.
- (ii) The Medal will be circular in shape, made of Gold coated one and three eighth inches in diameter and have embossed on the obverse the emblem of the Government of Tamil Nadu and year to which the award relates to at the bottom surrounded by the words in Tamil "போதைப்பொருள் உற்பத்தி சட்ட மற்றும் விரோத ஒழிப்பு கடத்தல் சிறப்பு பணிக்கான முதல்வரின் தமிழக பதக்கம்" காவல்

- On the reverse of it will have inscribed the words "தமிழக காவல்துறை" above and the state Moto "வாய்மையே வெல்லும்" below with the Temple motif in the center.
- (iii) The Medal shall only be awarded to those members of the All India Service / Tamil Nadu Police Service and other sub-ordinate ranks in the Sub-ordinate services of the Tamil Nadu Police for their outstanding work in eradicating the drug production and illicit trafficking in the State.
- (iv) To be eligible for the award of the Tamil Nadu Chief Minister's Police medal for outstanding work in eradicating the drug production and illicit trafficking in the State, the members of the service should have completed service for a period of not less than five years, consideration being given to those with longer years of service.
- (v) The names of those to whom the medal may be awarded shall be published in the *Tamil Nadu Government Gazette* and a Register of such names shall be kept by the Director General of Police/Head of Police Force, Tamil Nadu, Chennai as well as by the Government of Tamil Nadu in Home, Prohibition and Excise Department.
- (vi) Each Medal shall be suspended from the left breast and the riband of an inch and three eighths in width shall be half sky blue and half white. The ribands for the medals awarded on the earlier occasions shall be replaced by ribands with the appropriate colours as specified in this rule.
- (vii) The recipients of the Medal shall be granted a lumpsum grant of Rs.50,000/- each irrespective of ranks.
- (viii) The Medal is liable to be forfeited, when the holder is guilty of disloyalty, cowardice in action or such conduct, as in the opinion of the Government, brings the force into disrepute.
- (ix) It shall be competent for the Government to cancel and annul the award to any person of the above medal and thereupon his name in the register shall be erased. It shall, however, be competent for the Government to restore any medal which may have been so forfeited. Every person to whom the said decoration is awarded shall therefore receiving the same entered in to an agreement to return the medal if his name is erased as aforesaid. Notice of cancellation or restoration in every case shall be published in the *Tamil Nadu Government Gazette*. An undertaking in the following form shall be furnished by each awardee:-

UNDERTAKING

I,on whom the Government has been pleased to confer the Decoration of the Tamil Nadu Chief Minister's Police Medal for Outstanding work in eradicating the drug production and illicit trafficking in the State declare that I have read over and I understand the conditions attaching the Decoration and I hereby undertake to return the Decoration conferred upon me, should my name at any time be erased from the Register of persons upon whom the Medal shall have

been conferred upon my being called upon to do so, in accordance with the provisions of the Tamil Nadu Chief Minister's Police Medal for Outstanding work in eradicating the drug production and illicit trafficking in the State rules relating to the medal.

- (x) The members of service will be eligible for the grant of this medal in the State only once in their service. Those who have been awarded either Central or State Medal are not eligible for the award of Tamil Nadu Chief Minister's Police medal for outstanding work in eradicating the drug production and illicit trafficking in the State for the next three years.
- (xi) The nomination for the award of this medal shall not be done in a routine manner and should be done in all seriousness. The standard of cases reported shall be high.

The last ten years will be review period for considering for the award of this medal. Hence, the nominee should have clean defaulter sheet during the period of review.

- (xii) The recommendations of the District Superintendent of Police concerned may be routed through the Range Deputy Inspector General of Police and Zonal Inspector General of Police and Additional Director General of Police/ Head of Enforcement to the Director General of Police/ Head of Police Force, Chennai, on or before 28th day of the February every year for recommendations and onward transmission to Government before the 1st day of March every year.
- (xiii) The award may also be made posthumously. In this case, the lumpsum grant attached to the award will go to the legal heir of the medal awardee.
- (xiv) While wearing this Medal along with other Medals and decorations, it shall be worn to the left of the last medal awarded by the Government of India and next to Gandhi Adigal Medal received if any previously.
- (xv) To select nominees for this award, a committee considering of the following shall scrutinize the recommendations of the Director General of Police/Head of Police Force for the award of Tamil Nadu Chief Minister's Police medal for outstanding work in eradicating the drug production and illicit trafficking in the State and finalise the cases to be recommended for the award by the 20th day of April every year:-
 - a) Additional Chief Secretary/ Principal Secretary to Government, Home, Prohibition & Excise Department (Head of Home, Prohibition & Excise, Department)
 - b) Director General of Police/Head of Police Force, Tamil Nadu, Chennai.
 - Additional Director General of Police/Head of the wing, Enforcement.
 - d) Additional Director General of Police, Law and Order.

(xvi) While making recomendations for the Medal, it should be specifically reported whether nominee have at any time incurred any censure of a Court or have been concerned in proceedings that have been censured by the Courts of Law .
