It is notified for information of the public that in connection with introduction of 25 kV ac electric traction over the section of newly erected Overhead equipment, on newly laid track between Sengulam and Melapalayam from loc. 350/13 (km/ch.350/319) to loc. 352/23 (km/ch.352/582) and cross-over from loc. 351/29A (km/ch.351/885) to loc.352/10A (km/ch.352/258) in connection with the proposed flood carrier canal crossing RCC bridge at Km 351/300-400 in Thiruvananthapuram Division of Southern Railway, height gauges have been erected at all the level crossings with clear height of maximum 4.78m above road level with a view to prevent loads of excessive height from coming into contact or dangerous proximity to live traction wire (Contact wire), which shall be at a height of minimum 5.5m above the rail level at level crossings.

Public are hereby notified to observe e height specified above for the purpose of loading vehicles and to see that the loads carried in road vehicles do not infringe the height gauges under any circumstances.

The dangers of a load of excessive height are as follows.

i. Danger to the height gauge and consequent obstruction to the road as well as the Railway line.

- ii. Danger to the materials or equipment carried or the Vehicle itself.
- iii. Danger of fire and risk of life due to contact with or dangerous proximity to the conductors.
