In exercise of the powers conferred by Section 14 of the Tamil Nadu Payment of Salaries Act, 1951 (Tamil Nadu Act XX of 1951), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Legislators' (Medical Attendance and Treatment to former Members) Rules, 1982.

2. The amendments hereby made shall be deemed to have come into force on the 1st June 2023.
