

2. The Office of the Chief Judicial Magistrate, Tirunelveli, Official Receiver, Tirunelveli and Judicial Magistrate, Shencottah, Cheranmahadevi, Sivagiri and Radhapuram will remain open throughout the vacation and holidays declared above.

3. No Plaint or petition except application for grant of copies and Batta Memos for service and execution of Process will be received by the Civil Courts during the Vacation.

4. The Office of the Copyist, Process Service and Execution Department shall be kept open throughout the vacation and that no arrest warrant shall be executed during the vacation. The Office of the other departments shall remain closed.
