**Award of "Golden Jubilee Celebration of Women Police Force Medal (1973-2023)" to all Women Police Officers/Personnel of State Police to commemorate the Golden Jubilee Celebrations of Women Police Force in Tamil Nadu Police.**

No. II(2)/HO/895/2023.—The Hon'ble Chief Minister of Tamil Nadu has made an announcement on 17.3.2023 for a award of a new Medal to all Women Police Officers/Personnel of the State to commemorate the Golden Jubilee Celebrations of Women Police Force in Tamil Nadu Police (1973-2023):-

"பொன்விழா கொண்டாடும் இந்த ஆண்டில், பெண் காவல் ஆளினர்களின் திறமையை முழுமையாக அங்கீகரிக்கும் விதமாக, பெண்களை முதன்முறையாக காவல் பணியில் ஈடுபடுத்திய முத்தமிழறிஞர் தலைவர் கலைஞர் அவர்களது நினைவாக, அவரது பெயரில் கலைஞர் காவல் பணி விருது வழங்கப்படும்."

2. Pursuant to the announcement made by the Hon'ble Chief Minister of Tamil Nadu on 17.03.2023, the Director General of Police/Head of Police Force in the letter first read above has proposed to institute a new Medal to award all Women Police Officers/Personnel (35,329) of Tamil Nadu Police to Commemorate the Golden Jubilee Celebration (1973-2023).

3. Accordingly, the Government of Tamil Nadu instituted an award named "Women Police Force Medal" to embellish the "Golden Jubilee Celebration of Women Police Force in Tamil Nadu Police (1973-2023)" to award all Women Police Officers/Personnel (35,329) in all ranks of the Tamil Nadu Police and hereby makes the following Rules Governing the award of the said medal:-

- This Medal shall be designated as "Golden Jubilee Celebration of Women Police Force Medal (1973-2023)"
- This Medal may be conferred to all Women Police Officers and Personnel (35,329) in all ranks of the Tamil Nadu Police, as one time measure.

- This Medal will be circular in shape, made of Cupro-Nickel 35mm in diameter and fitted to a plain horizontal bar with standard fitness.
- It shall have embossed on the obverse the image of the Women above the image have "தமிழ்நாடு காவல்துறை" and at the bottom surrounded by the Year 1973-2023 (to which The Golden Jubilee Celebration). On the reverse of it, it will have inscribed the words in the middle circle "தமிழ்நாடு காவல்துறை" above and the state motto "வாய்மையே வெல்லும்" below with the Temple motif in the center and outer circle it will have inscribed the words "காவல்துறையில் பெண்கள்—பொன்விழா ஆண்டு தமிழ்நாடு காவல்துறை 1973 - 2023"
- The Medal shall be worn suspended from the left breast by a silk Ribbon of white and Lavender colour.
