No. SRO B-47/2023.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Agricultural Engineering Service (Section 38 in Volume II of the Tamil Nadu Services Manual, 2016.)

2. This amendment shall be deemed to have come into force with effect on and from the 24th July, 2013.

AMENDMENT

In the said rules, in rule 2 for sub-rule (b), the following sub-rule shall be substituted, namely :-

"(b) Appointment to vacancies arising in class IV shall be made by promotion from among the holders of the post of Assistant Engineer in class V and by recruitment by transfer from among the holders of the post of Junior Engineer in the Tamil Nadu Agricultural Subordinate Service in the ratio of 3: 1 in the following order of rotation, namely :-

- (v) By promotion;
- (vi) By recruitment by transfer;
- (vii) By promotion; and
- (viii) By promotion:

Provided that the above ratio of 3: 1 shall be deemed to have come into force on and from 24.07.2013 and prior to this date, the erstwhile ratio of 3:2 shall apply."
