Notifications under the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act.*[G.O. No. SR.I/72-20/2023, Public (S.C.), 17th November 2023.]*

No. II(1)/PU/35/2023.—WHEREAS, an order had been made by the Government of Tamil Nadu in G.O.No.SR.I/72-9/2023, Public (SC) Department, dated 10.10.2023 under section 3(1)(i) of the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (Central Act 52 of 1974), directing that Thiru Bakker Hussain, S/o. Thiru Ali Thambi, resident of No. 02, Velayutham Street, Radha Nagar, Chrompet, Chennai-600 044, be detained;

AND WHEREAS, the said Thiru Bakker Hussain, S/o. Thiru Ali Thambi, resident of No. 02, Velayutham Street, Radha Nagar, Chrompet, Chennai-600 044, cannot be found;

AND WHEREAS, the Government of Tamil Nadu have reasons to believe that the said Thiru Bakker Hussain, S/o. Thiru Ali Thambi, resident of No. 02, Velayutham Street, Radha Nagar, Chrompet, Chennai-600 044, in respect of whom the detention order has been made, has absconded and is concealing himself so that the said detention order cannot be executed.

NOW, THEREFORE, in exercise of the powers conferred by section 7 (1) (b) of the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (Central Act 52 of 1974), the Government of Tamil Nadu hereby direct the said Thiru Bakker Hussain, S/o. Thiru Ali Thambi, resident of No. 02, Velayutham Street, Radha Nagar, Chrompet, Chennai-600 044, to appear before the Commissioner of Police, Tambaram City Police, Sholinganallur, Chennai - 600 119 at his office within a period of 15 days (fifteen days) from the date of publication of this order in the *Tamil Nadu Government Gazette*.

Srinivasan, Secretary, Legislative Assembly Secretariat and Secretary, Tamil Nadu Legislative Assembly be granted extension of service on public grounds for three years from 01-12-2023 FN subject to the outcome of W.P. Nos. 3856/2018 and 4394/2018 pending before the High Court of Madras.

ORDER: No. 103, Legislative Assembly Secretariat, 30th November 2023.

Sanction is accorded for the upgradation of the permanent post of Secretary, Tamil Nadu Legislative Assembly Secretariat and Secretary, Tamil Nadu Legislative Assembly as Principal Secretary, Tamil Nadu Legislative Assembly Secretariat and Principal Secretary, Tamil Nadu Legislative Assembly in the level of pay of Rs. 1,28,900 - 2,61,000 (Level 32) with effect from 1.12.2023 FN, keeping in abeyance the post of Secretary, Tamil Nadu Legislative Assembly Secretariat and the Secretary, Tamil Nadu Legislative Assembly.

2. The upgraded Post of Secretary, Tamil Nadu Legislative Assembly Secretariat and Secretary, Tamil Nadu Legislative Assembly as Principal Secretary, Tamil Nadu Legislative Assembly Secretariat and Principal Secretary, Tamil Nadu Legislative Assembly shall be treated as higher in the rank to that of Secretary, Tamil Nadu Legislative Assembly Secretariat and Secretary, Tamil Nadu Legislative Assembly.

3. The upgraded post of Principal Secretary, Tamil Nadu Legislative Assembly Secretariat and the Principal Secretary, Tamil Nadu Legislative Assembly shall constitute a distinct category under Class I (Group-A) of the Tamil Nadu Legislative Assembly Secretariat Service.

4. The Appointing Authority shall be the Governor of Tamil Nadu.

5. The Principal Secretary, Tamil Nadu Legislative Assembly Secretariat and the Principal Secretary, Tamil Nadu Legislative Assembly shall exercise the powers, perform the functions and discharge the duties and responsibilities of the Secretary, Tamil Nadu Legislative Assembly Secretariat and the Secretary, Tamil Nadu Legislative Assembly.

6. The expenditure shall be debited to the following head of account:-

"2011 Parliament/State/Union Territory Legislatures - 02 State/Union Territory Legislatures - 103 Legislative Secretariat - State's Expenditure - AA State Legislative Assembly Secretariat - 01 Salaries" (DPC 2011 02 103 AA 0101).
