No. SRO A-4/2023.—The following Notification of the Government of India Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) New Delhi, the 30th December, 2022 is republished:-

G.S.R. 929(E).-In exercise of the powers conferred by sub-section (1) of section 3 of the All India Services Act, 1951 (61 of 1951), read with sub-rules (1) and (2) of rule 4 of the Indian Administrative Service (Cadre) Rules, 1954, the Central Government, in consultation with the Government of **Tamil Nadu**, hereby makes the following regulations further to amend the Indian administrative Service (Fixation of Cadre Strength) Regulations, 1955, namely:-

- 1. (1) These Regulations may be called the Indian Administrative Service (Fixation of Cadre Strength) Fourth Amendment Regulations, 2022.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Indian Administrative Service (Fixation of Cadre Strength) Regulations, 1955, in the Schedule, for the heading **"Tamil Nadu"** and the entries relating thereto, the following shall be substituted namely:-
