

No. I/PUSP/7/2023.—The Government of Tamil Nadu record with deep and profound regret the untimely death of one of its Senior Officers, Thiru C. Kathiravan, IAS, Project Director, Tamil Nadu Road Sector Project II, Chennai on 17th February 2023 at the age of 52 years.

He started his career as an Agriculture Officer from 12.09.1996 and entered into Tamil Nadu State Civil Services as Probationary Deputy Collector, in Dharmapuri District on 25.01.2002 and held various posts including Revenue Divisional Officer Kallakurichi, Aranthangi and Villuppuram; Personal Assistant (General) to Collector, Villuppuram; District Revenue Officer, Villuppurarm and Tiruvannamalai. He has got conformant in the Indian Administrative Service on 27.12.2013 and held various posts including General Manager, Aavin, Salem; Commissioner, Corporation of Madurai; Collector, Krishnagiri and Erode; Managing Director, TANMAG, Salem and now the Project Director, Tamil Nadu Road Sector Project II, Chennai.
