TAMIL NADU LEGISLATIVE ASSEMBLY

Amendment to the Special Rules for Tamil Nadu Legislative Assembly Secretariat Service.

[S.O. Ms. No. 36, Legislative Assembly Secretariat, 12th April 2024, Panguni 30, Sobakiruthu, Thiruvalluvar Aandu-2055.]

No. SRO B-17/2024.

In exercise of the powers conferred by clause (3) of Article 187 of the Constitution of India, the Governor of Tamil Nadu, after consultation with the Speaker of the Tamil Nadu Legislative Assembly, hereby makes the following amendment to the Tamil Nadu Legislative Assembly Secretariat Service Rules:-

AMENDMENT.

In the said Rules, after rule 27, the following rule shall be inserted namely:

"27-A. Test to be passed by the English Reporters / Tamil Reporters / Steno-Typists / Typists including Tamil Typists" - Every person appointed to the Category of English Reporter (or) Tamil Reporter (or) Steno-Typist (or) Typist including Tamil Typist shall pass the "Certificate Course in Computer on Office Automation" awarded by the Directorate of Technical Education within the period of his probation. Otherwise he will be dealt with as per the provision under rule 11 of the Tamil Nadu Legislative Assembly Secretariat Service Rules:

Provided that those who possess a degree (or) diploma in Computer Science (or) Computer Engineering (or) Computer Application (or) Information Technology (or) Software Engineering (or) Computing (or) Computer Information Systems (or) Computer Design approved by the University Grants Commission (or) All India Council for Technical Education (or) Directorate of Technical Education (or) an equivalent body shall be exempted from passing the "Certificate course in Computer on Office Automation" conducted by the Directorate of Technical Education.

Provided further that the existing employees in the above categories who are in service on the date of publication of this Notification shall be exempted from passing the "Certificate Course in Computer on Office Automation"."

Amendment to the Special Rules for Tamil Nadu Architect Service.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Architect Service (Section 41 in Volume II of the Tamil Nadu Services Manual 2016).

AMENDMENT

In the said Special Rules, in rule 4, in sub-rule (a), for the expression "the first day of July of the year in which the selection for appointment is made", the expression "the first day of July of the year in which the vacancy is notified" shall be substituted.
