Notice is hereby given that an election by direct polling is to be held in the University premises for electing two members to the Governing Council of The Tamil Nadu Dr. M.G.R. Medical University, Chennai, as per clause (b) of sub-section (4) of Section 21 of The Tamil Nadu Dr. M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) by the Deans/Principals of the affiliated Colleges providing courses of Study and training in Medical Science from among themselves to fill the arising vacancies. The term of membership in the Governing Council will be for a period of 03(Three) years from the date of publication of the results of the election or the date on which he/she holds the post of Deans/Principals of the affiliated colleges whichever is earlier.
