Amendment to the Special Rules for the Tamil Nadu General Subordinate Service.

[G.O. Ms. No. 518, Law (OP-III), 13th May 2024]

- No. SRO B-21/2024.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Subordinate Service (Section 13 in Volume III of the Tamil Nadu Services Manual, 1970).
- 2 . (a) The amendments hereby made except the amendment made in clause 1(A) shall come into force on and from the date of publication in the *Tamil Nadu Government Gazette*.
- (b) The amendment made in clause 1 (A) shall be deemed to have come into force on the 13th day of September 2021 .

AMENDMENTS.

In the said Special rules in Part- II, under the heading "CLASS-III, TRANSLATION OFFICER AND TRANSLATOR IN THE TAMIL CELL, LAW DEPARTMENT",-

- 1. in rule 3,
 - (A) in sub- rule (a), for the expression "thirty years", the expression "thirty two years" shall substituted;
 - (B) in sub-rule (b), in the TABLE, in column (3),-
 - (a) against the entries "(1) Translation Officer" in column (1) and ,-
- (1) "(i) Direct Recruitment" in column (2), for item (i), the following item shall be substituted, namely:-
- "(i) Must possess a degree in Law awarded by any University or Institution recognized by the University Grants Commission and recognised by the Bar Council of India for the purpose of enrolment as an Advocate; and ";
- (2) "(iii) Recruitment by transfer from any other Service" in column (2), for item (i), the following item shall be substituted, namely;-
- "(i) Must possess a degree in Law awarded by any University or Institution recognised by the University Grants Commission and recognised by the Bar Council of India for the purpose of enrolment as an Advocate; and";
 - (b) against the entries "(2). Translator" in column (1) and, -
 - (1) "(i) Direct recruitment" in column (2), for item (i), the following item shall be substituted, namely:-
- "(i) Must possess a degree in Law awarded by any University or Institution recognised by the University Grants Commission and recognised by the Bar Council of India for the purpose of enrolment as an Advocate; and";
- (2) "(iii) Recruitment by transfer from any other service" in column (2), for item (i), the following item shall be substituted, namely;-
- "(i) Must possess a degree in Law awarded by any University or Institution recognised by the University Grants Commission and recognised by the Bar Council of India for the purpose of enrolment as an Advocate; and";
 - 2. after rule 5, the following rule shall be: inserted, namely:-
- "5A. Training.- Every person appointed to the categories of Translation Officer and Translator by direct recruitment shall undergo the Foundational Training for a period of two months and pass the examination conducted at the end of such training within the period of his probation" .
 - 3. in rule 6, in the TABLE, in column (2) . -
- (a) for the expression "Rs. 15,600-39,100+ Grade Pay Rs. 5,400/-, the expression" Level 22-56,100-2,05,700" shall be substituted.
- (b) for the expression "Rs. 9,300-34,800 + Grade Pay Rs. 4,600/-", the expression "Level 16-36, 400-1 ,34, 200" shall be substituted.
