No. II(2)/HE/493/2024.— In the matter of the Charitable Endowments Act, 1890 (Central Act VI of 1890) and in the name of "Thirumathi Meenakshi Panchanatham Memorial Endowment Fund" (hereafter referred to as "the said Endowment") tenable in the Alagappa Government Arts College, Karaikudi-630 003.

I. VESTING OF PROPERTIES.

WHEREAS, an application has been made to the Government of Tamil Nadu under clause (b) of sub-section (1) of Section 6 of the Charitable Endowments Act, 1890 (Central Act VI of 1890) by Dr. Ramanathan P.Nachiappan, the donor of the said Endowment for vesting the property specified in the Schedule below, in the Treasurer of Charitable Endowments, Chennai, appointed under section 3 of the said Act for the State of Tamil Nadu. THE SCHEDULE

 The fund shall be called "Thirumathi Meenakshi Panchanatham Memorial Endowment Fund tenable in the Alagappa Government Arts College, Karaikudi-630 003.

NAME

- The said fund shall be administered by the Endowment Committee.
- 3. From and out of the annual interest accured on the fund,
 - (a) A prize money of Rs.15,000-/ (Rupees Fifteen Thousand only) shall be given to one meritorious student who is having highest aggregate marks in B.Sc. Geology Programme among the students who studied B.Sc.Geology programm in Alagappa Government Arts College, Karaikudi and pursuing his/her M.Sc. Geology at Alagappa Government Arts College, Karaikudi;
 - (b) A prize money of Rs.15,000/- (Rupees Fifteen Thousand only) shall be given to one meritorious student who scored high aggregate marks in the four semesters of M.Sc. Geology among the M.Sc. Geology students of Alagappa Government Arts College, Karaikudi.
- 4. If the aforesaid students are selected for other similar such endowment award, then the next highest scorer will be considered to be an eligible student to avail this endowment prize.
- If more than one student secures the equal marks, the prize money shall be equally distributed among them.
- The mode by which the interest amount shall be given to the student may be specified by the Administration.
- 7. The unutilized amount of the interest shall be added to the corpus of the said Fund.
- The decision of the administrator shall be final, in all matters relating to the administration of the said fund.
