

Amendment to the Adhoc Rules retaling to the Temporary Post of Assistant Director (Technical) in the Central Survey Office, Chennai for the Tamil Nadu Survey and Land Records Service.

No. SRO B-22/2024.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 5th December 2019.

RULES

The Tamil Nadu Government Servants (Conditions of Service), Act 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts of Assistant Director of Survey and Land Records in Class I of the Tamil Nadu Survey and Land Records Service shall apply to the holders of the temporary post of Assistant Director (Technical) in the Office of the Joint Director of Survey, Central Survey Office, Chennai subject to the modifications specified in the following rules, namely:-

2. Constitution

The post of Assistant Director (Technical) shall constitute a separate category in Class I of the Tamil Nadu Survey and Land Records Service.

3. Reservation of appointment

The provision contained in Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) shall apply to the post of Assistant Director (Technical).

4. Appointment

Appointment to the post shall be made by recruitment by transfer from the post of Technical Officer in Category I in Class II of the Tamil Nadu Survey and Land Records Subordinate Service.

5. Age

Must not have completed fifty nine years of age on the first day of July of the year, in which the selection for appointment is made.

6. Crucial date

The crucial date for the preparation of the annual list of approved candidates for appointment to the post shall be the 22nd February of every year.

7. Probation

Every person appointed to the post, shall from the date on which he/she joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

8. Pay

There shall be paid to the holder of the post, a monthly pay in the level based pay matrix at Level 22 Rs.56,100-2,05,700.
